I thought it was the most beautiful piece of clothing I had seen in a long time. It was a dark red corduroy material with gold buttons on the straps and one on each front pocket. I could not wait to wear it.



I was in heaven until the girl next to her said "yes it is nice, my mother donated it to the poor people last month, it use to be mine". I was never so embarrassed. When I got home I threw the red jumper that had made me so happy into the back of my closet and never wore it again."

# Dear Alice's Kids,

"The family is located in South Memphis in a 2 bedroom house, Mom is unemployed but very involved in the boys schooling and extra-curricular activities. Student is an 8th grader who was very troubled in the beginning of the school year. When I met him, he was on his 3rd suspension and being kicked off the basketball team. We sat down and created a program that helped him become more familiar with others and how to focus more on positives at his new school vs. the negatives. He now wants to run for Homecoming King but doesn't have the proper suit or shoes."

We paid for the items and recently received this from the teacher:

"The student went shopping with me to a mall in our city. He finally chose one suit within his budget and liking. The day of homecoming, he was overly excited and nervous. He was back on the basketball team and at half time the announcements came. AND....He won Homecoming King!!!! He was so ecstatic and finished the game with more motivation that led to our team winning.

Since the event, the student has calmed down and feels more like a part of our school and Memphis. He is taking ownership of his decisions (which have improved drastically) and he is holding his peers accountable as well. The student's mom has noticed him being more of a positive big brother as well and he takes on chores that haven't been assigned to them. The last change I've noticed in this student is his willingness to forgive and agree to disagree. Thank you Alice's Kids!!"

## Sample Cases in January:

• Assisted with purchase of winter boots for 13 year old young man who wears adult shoe size.

- Bought dress shoes for 12 year old young man to dress for away basketball games.
- Purchased safety car sea for 8 year old boy with developmental delays.
- Paid senior STEM program dues for year old young man.

• Paid fee for youth trip conference for 16 year old young man who is currently living with his aunt and sometimes with church members while his Aunt travels to help her daughter with cancer treatment.

• Assisted 17 year old young lady to pay for college books. The student works and takes 4 college classes while still in high school.

• Paid ROTC fee for 16 year old young man whose grandmother is caretaker for him and his sibling.

• Purchased skateboard for 16 year old to use for transportation to HS.

• Bought art supplies for 16 year old boy who has traumatic brain injury due to abuse of birth father.

• Paid fee for 19 year old young man to get his birth certificate which he needs to apply for college and financial aid.

• Bought gift card to enable homeless, single mom to get birthday gifts for 8 year old daughter.

•Purchased appropriate attire for 17 year old high school senior who is being awarded a football scholarship at special ceremony at his school.

•Bought soothing sounds clock radio to help 11 year old young lady fall asleep. She has PTSD due to sexual abuse, depression and anxiety.
